To amend title XVIII of the Social Security Act to protect beneficiaries with limb loss and other orthopedic conditions by providing access to appropriate, safe, effective, patient-centered orthotic and prosthetic care; to reduce fraud, waste, and abuse with respect to orthotics and prosthetics, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Medicare Orthotics and
- 5 Prosthetics Patient-Centered Care Act".

1	SEC. 2. INCREASING PROTECTIONS FOR MEDICARE BENE-
2	FICIARIES RECEIVING ORTHOTIC AND PROS-
3	THETIC CARE.
4	(a) Prohibition on Payment for Items Deliv-
5	ERED BY DROP SHIPMENT.—
6	(1) In General.—Section 1834(h)(1) of the
7	Social Security Act (42 U.S.C. 1395m(h)(1)) is
8	amended by adding at the end the following new
9	subparagraph:
10	"(I) Prohibition on payment for cer-
11	TAIN ITEMS FURNISHED USING A DROP SHIP-
12	MENT.—
13	"(i) In general.—No payment shall
14	be made under this subsection for an item
15	described in clause (ii) furnished to an in-
16	dividual via a drop shipment.
17	"(ii) Items described.—This items
18	described in this clause are the following:
19	"(I) A prosthesis (as defined in
20	paragraph (4)(C)), except that such
21	term does not include supplies for
22	such prosthesis.
23	"(II) A custom-fabricated ortho-
24	sis (as described in subparagraph
25	(F)(ii)), or a custom-fitted orthosis,

1	except that such term does not in-
2	clude supplies for such orthosis.
3	"(III) Off-the-shelf orthotics (as
4	defined in section $1847(a)(2)(C)$) that
5	are not otherwise subject to competi-
6	tive bidding and are delivered by drop
7	shipment.
8	"(iii) Drop shipment defined.—In
9	this subparagraph, the term 'drop ship-
10	ment' means the direct shipment of a pros-
11	thesis or an orthosis to an individual that
12	has not received training or education with
13	respect to fitting and adjustment or train-
14	ing in the care and use of such prosthesis
15	or orthosis from a qualified practitioner
16	(as described in subparagraph (F)(iii)).".
17	(2) Effective date.—The amendment made
18	by paragraph (1) shall apply to items furnished on
19	or after the first day of the first full calendar year
20	following the date of enactment of this Act.
21	(b) Additional Practitioners Exempt From
22	Competitive Acquisition.—Section $1847(a)(7)(A)(i)$ of
23	the Social Security Act (42 U.S.C. 1395w–3(a)(7)(A)(i))
24	is amended—

1	(1) by inserting ", physical therapist, occupa-
2	tional therapist, orthotist, prosthetist" after "by a
3	physician"; and
4	(2) by inserting ", physical therapist, occupa-
5	tional therapist, orthotist, prosthetist" after "the
6	physician's" in each place such term occurs.
7	(c) Ensuring Beneficiary Access to Replace-
8	MENT CUSTOM-FITTED ORTHOTIC DEVICES AND CUS-
9	TOM-FABRICATED ORTHOTIC DEVICES.—Section
10	1834(h)(1)(G) of the Social Security Act (42 U.S.C.
11	1395m(h)(1)(G)) is amended—
12	(1) in the heading, by inserting ", Custom-
13	FITTED ORTHOTIC DEVICES, CUSTOM-FABRICATED
14	ORTHOTIC DEVICES," after "REPLACEMENT OF
15	PROSTHETIC DEVICES"; and
16	(2) in clause (i), by inserting ", replacement of
17	custom-fitted orthotic devices, replacement of cus-
18	tom-fabricated orthotic devices," after "which are
19	artificial limbs,".
20	(d) Updating Definitions of Orthotics and
21	Prosthetics.—Section 1834(h)(4)(C) of the Social Se-
22	curity Act (42 U.S.C. 1395m(h)(4)(C)) is amended by
23	striking "the term orthotics and prosthetics has the
24	meaning given such term", and inserting "the terms

- 1 'orthotics and prosthetics' and 'orthoses and prostheses'
- 2 have the meaning given such terms".
- 3 (e) REGULATIONS.—Not later than 1 year after the
- 4 date of the enactment of this Act, the Secretary of Health
- 5 and Human Services shall promulgate final regulations to
- 6 implement the amendments made by this Act.
